## REPRESENTATIVE EXPERIENCE

- Representation of a general contractor in a highly contested claim
  that it was wrongfully terminated by a steel mill on a multimilliondollar project. Following a three-and-a-half week jury trial, the jury
  found in favor of Hahn Loeser's client, awarding \$3.5 million and
